The Oakwood City School District Board of Education is seeking qualified candidates for the position of superintendent. The board seeks an innovative leader to fill the vacancy created by the retirement of Dr. Mary Jo Scalzo, who has served the district for 20 years and has served as superintendent since 2004. Kathy LaSota, director of school board services at the Ohio School Boards Association, is assisting the board in its search.

About the District

Doing what is best for students is the district's guiding principle. To this end, the Oakwood City School District commits the resources, support, expertise and experiences needed for all students to achieve.

The Oakwood City School District, with an enrollment of 2,074 (2012-2013), offers a differentiated and rigorous pre-K-12 program of instruction that prepares graduates for their postsecondary pursuits. Lange School serves kindergartners and houses the district's beforeand after-school child care program. Edwin D. Smith School serves preschoolers and students in grades 1-6.
